Membership:

1. Full Member: to qualify as a Full Member, one must:

(a) be a Malaysian Citizen, 18 years and above and,

(b) have published, released or publicly performed a minimum of three of their works in contemporary music, their works can be in any instrumentation from solos to orchestra. Alternatively, one must be invited by the Committee.

2. Associate Member: this is by application of individuals who are not composers but interested in contemporary music or by invitation of the Committee to persons who are supportive of the Society's aims. They cannot be vote and voting.

3. Honorary Member: this is by invitation of the Committee to persons who the Committee believes are able to play a vital role in the development and well-being of the Society. They cannot be vote and voting.

4. Preparatory Member: this is open to student composers who are yet unable to fulfill the criteria for full membership. Any composer presently enrolled as a full-time student or studying composition privately may apply. At least one composition by the applicant should be presented to the Committee for consideration for membership. Preparatory membership will be reviewed by the Committee regularly; upon invitation to become a Full Member, his/her Preparatory membership will be given up.
